SALES FROM OUR RETAIL STORES ARE THE PRIMARY SOURCE OF INCOME FOR GIUMSC (GROSS SALES \$53,817,200), ENABLING US TO PROVIDE EDUCATION AND TRAINING SERVICES FOR PEOPLE IN THE COMMUNITIES WE SERVE AND TO PLACE 5,962 PEOPLE INTO EMPLOYMENT DURING THE 2023-2024 FISCAL YEAR. OUR RETAIL STORES ALSO PLAY A KEY ROLE IN OUR MISSION AS TRAINING SITES FOR INDIVIDUALS IN GIUMSC'S TRAINING PROGRAM AND BY OFFERING LONG-TERM EMPLOYMENT OPPORTUNITIES FOR 627 INDIVIDUALS MANY OF WHOM HAVE BARRIERS TO EMPLOYMENT. THESE ORGANIZATIONAL EMPLOYMENT SERVICES (OES) INCLUDE HEALTH AND RETIREMENT BENEFITS, PERSONAL AND PROFESSIONAL DEVELOPMENT OPPORTUNITIES AND POTENTIAL FOR CAREER ADVANCEMENT. EACH OF THE 10,294 PEOPLE SERVED PARTICIPATED IN AT LEAST ONE (AND GENERALLY MORE) OF THE SERVICES WE PROVIDE.
